BLUEPRINT OF THE PROJECT:

DATABASE AND CATALOGUING FOR THE PURPOSE OF PREPARING STATE LEVEL REGISTER FOR INVENTORY OF ICH OF TRIPURA

1). Brief introduction of the Project: The Project titled **Database and Cataloguing for the purpose of Preparing a State Level Register for Inventory of Intangible Cultural Heritage of Tripura** - means undertaking a research work of preparing a database relating to all necessary information of cultural activities which are intangible in nature and may be included under Intangible Cultural Heritage of Tripura. The work will also include the Cataloguing of the intangible cultural elements according to their nature and characteristics. Finally, we will prepare a State-level Register based on this research and the collected data which will furnish basic information related to Intangible Cultural Heritage of Tripura.

2). Objectives of the research, data creation or documentation of the Project:

Tripura, though a tiny state of North East India, is demographically and culturally diverse in nature. The Bengalese, mainly migrated from erstwhile East Pakistan, came to this land of hills with various popular traditional folk cultures forming the majority of population (70%). There are also 19 Tribal communities in Tripura having strong folk -cultural heritage. Besides, two major ethnic groups, there are also Manipuri and some other minority groups which all together make Tripura a land of multi-coloured cultural tradition. But due to the aggressive spreading of so called modern and Western culture all over the North Eastern States, the rich folk cultural heritage of the State is confronting a serious threat. The practices of these intangible cultures become shrinking day by day which may be considered as endanger cultural element. If initiatives are not taken immediately to safeguard these intangible cultural elements, one day will come very soon when they will be extinct. So, the Project will primarily cater the basic data and related information of the cultural element associated to these intangible cultures of the State of Tripura on which further research or safeguarding projects may be taken.

3). Implementation of the Project: Tripura is a tiny State of North East India having 10,980 sq.km areas with international border with Bangladesh in three sides. Tripura has 37 lacs of population in which 70% is Bengali speaking people while rest is Kokborak (language of the Tribal people) speaking. It was a Princely State ruled by Maharajas of Manikya families. On 15th October, 1949, Tripura merged with independent India.

Now, Tripura has the following administrative set-up.

Artists associated with intangible cultural heritages reside scattered all over the State. There are also some localities where mobilization of particular community and practice their particular cultural form which makes an acquaintance of the locality. The field workers will follow the following ways :

i). Taking reference from Panchayat Secretary and Gaon Pradhan of Gaon Panchayet, the field workers will meet the artist associated with intangible cultural element and collect necessary information .

ii). Field workers will also meet the Gurus, if available, who run any sort of training centre of any intangible cultural element and take the necessary information.

iii). The intangible cultural elements are presented by different community in various cultural festivals and functions held at all over the state. The video recording and photograph of the elements will be taken from these live shows for incorporating in database.


iv). Based on the data and information collected by the field workers, a Database will be prepared to make a Register cataloguing each intangible art form separately. Finally, a State level Register for inventory of Intangible Cultural Heritage will be developed as follows:

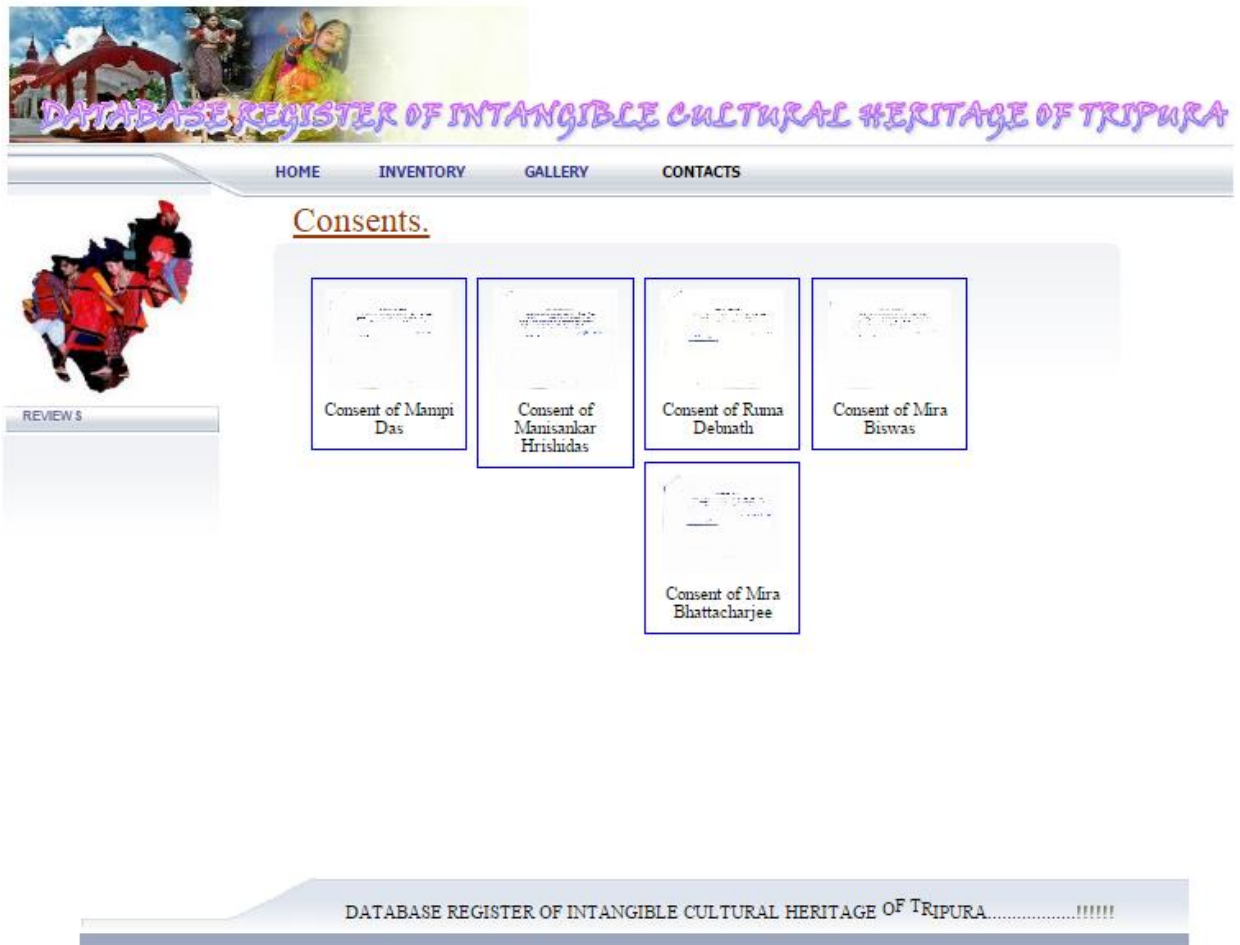

The Koloï Community worships the Garia Puja on the seventh day of Baishakh of bengali month. The Symbolic Garia Deity is represented with the shell. This is the common code of the community of image construction. A Risa is hanged on the shell. A charm dance with song is performed by the young boys and girls. In the evening the symbolic image is emerged into the lake. The music performed with the dance and song is like
" OH GORJA RAJA....."

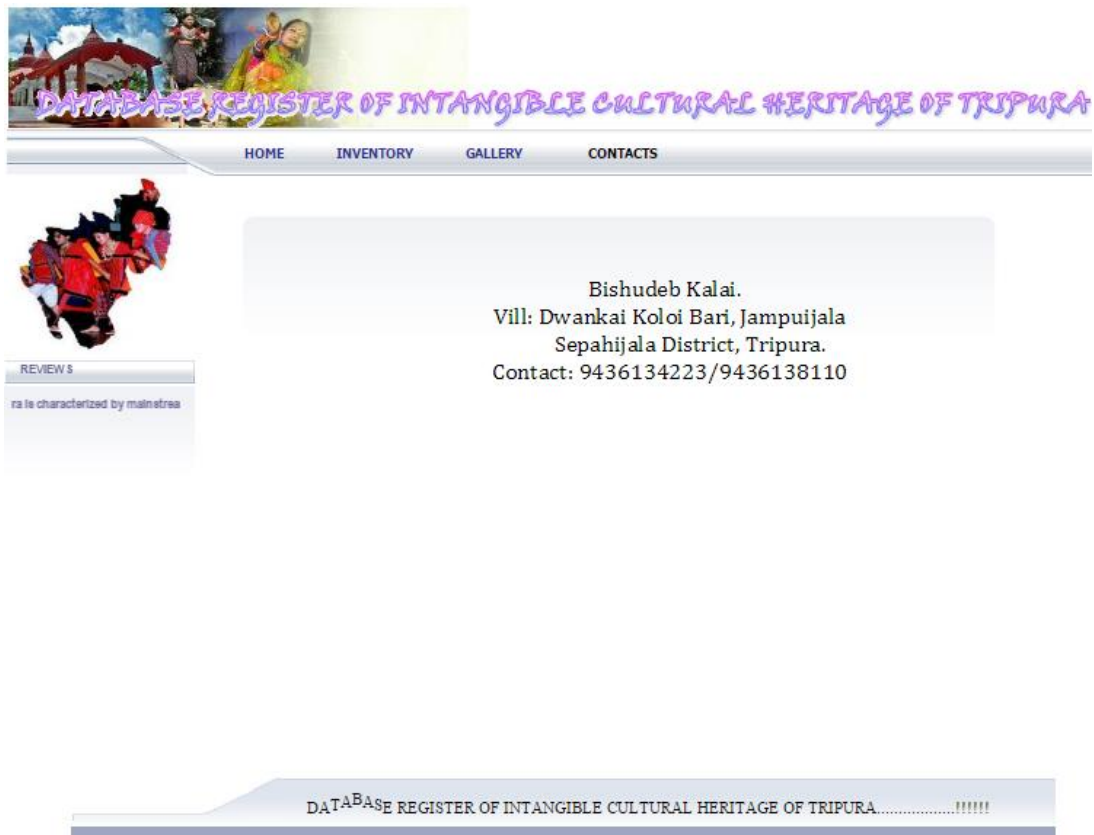
